Governance

Financial Information

The UIA-PHG at this time does not create an annual budget, The UIA-PHG does not have any income or direct expenses.

All events are the fiscal responsibility of the host. In the past, events have been funded directly by the host, members, and / or guests (event registration for seminar or competition). All sponsorship for UIA-PHG associated events are the responsibility of the hosting committee, and these funds are not available for the use of the UIA-PHG.

The current expense of the UIA-PHG website is currently financed by the Australian Institute of Architects (AIA).

Activities

The activities of the UIA-WP Public Health are determined by a lively exchange of information and mutual assistance among its members, the national sections, the national and international organizations and institutes of health and hospital care. The members also contribute through scientific and professional work, reports, publications and organizational work.

The main annual activity is the International Public Health Seminars (IPHS) which where possible are jointly organized with either the IHF and WHO, and/or the International Hospital Congresses, where the UIA-PHG organises their discussion groups on architecture and its impact on engineering and facility management aspects. The subjects of the IPHS have always been given special consideration, reflecting either subjects of current interest to health facility architects or to supplement the themes of the congresses with whom the UIA-PHG is sharing arrangements.

The UIA-PHG also represents the Union and the Group at various other events e.g. World Health Organization (WHO) assemblies and conferences, congresses on primary health care, nursing, hospital engineering, interstitial space, energy conservation, fire protection and others. In the recent past, joint conferences, (e.g. with the Academy Architecture for Health of American Institute of Architects (AIA), Royal Canadian Institute of Canada (RAIC), TESIS-Florence, Technical Chamber of Greece, International Hospital Federation (IHF), United Architects of Philippines, BDA-AKG, China Hospital Construction Conference, SALUS, and the Australian Institute of Architects) show the progress in the exchange of information toward the architects in practice.

Over the past 12 months, the UIA Public Health Group has progressed in undertaking the following activities:

Annual International Public Health Seminar (IPHS)

Each year the UIA-PHG organises an annual Seminar of 3 days duration (2-day seminar + 1-day tours) to which all members of the UIA-PHG are invited to share their national perspective on recent developments in the planning and design of health facilities.

2017 International Public Health Seminar (IPHS)

The IPHS for 2017 was held in London, England 11 – 14 June 2017 in conjunction with the European Healthcare Design Congress, and in partnership with SALUS. The 2017 seminar was coordinated by Cliff Harvey, Canada with the support of Warren Kerr, UIA-PHG Director, Australia; Marc Sansom, Salus; and Katie Wood, Arup.

The 2017 IPHS attracted an excellent response for presentation papers and resulted in another highly successful forum for the discussion and exchange of information and ideas regarding the planning and design of health facilities. Details of the papers and content of the 2017 IPHS are currently being compiled and considered for publication.

In addition, the UIA-PHG organised a second IPHS in Sydney Australia during the period 26-29 September 2017. This Seminar was conducted in conjunction with the annual Congress of the Australasian College of Health Service Management (ACHSM), the Australian Institute of Architects, and the Australian Health Design Council. I wish to commend the work of Warren Kerr, Australia, UIA-PHG Director (2013-2017), for his work on organizing this event.

Guest speakers included Dr Ray Pentecost, the Director of the Center for Health Systems and Design at Texas A&M University and the 2017 President of the American College of Healthcare Architects, Mr Darryl Carey the Chair of the New Zealand Health Design Council, MS Kate Copeland, the Chair of the Australian Health Design Council and Gunther de Graeve, the new CEO of the International Academy for Design & Health. In addition to three days of presentations, those attending were also invited to participate in tours to four recently completed hospital projects in Sydney – Blacktown Hospital, Mt Druitt Hospital, St Vincent's Hospital and the Prince of Wales Hospital.

2018 IPHS

At the annual meeting a proposal to host the 2018 IPHS in Paris, France, from Mr Thomas Schinko, France and the Paris Healthcare Week was accepted. The dates of the seminar is May 29-31, 2018. Additional information can be found at: <https://www.uia-phg.org>

Future IPHS

2019 IPHS

Discussions are underway for a location for the 2019 IPHS. The Healthcare Design Council has forwarded a proposal to host the 2019 IPHS in Christchurch, New Zealand in August 2019. This proposal will be presented and voted on at the UIA-PHG annual meeting in Paris in May 2018.

2020 IPHS

Previously, Walkiria Erse, Brazil offered to host the 2020 Seminar in Rio de Janeiro, Brazil in conjunction with the UIA Congress. This proposal was accepted. The intention of the UIA-PHG is to hold our annual Seminar in conjunction with the UIA Congress scheduled for September 2019. We are aware of the need to have any interaction with the main Congress formally approved by the UIA and will be working to establish an indicative program over the coming year.

2017 UIA-PHG Student and Young Architects' Competition

In 2016, the UIA International Competition Commission approved a Student and Young Architects ideas competition to be conducted by the UIA-PHG with support of the 2017 China Hospital Conference in Wuhan, China. The theme of the student competition was Smart, Green & Beyond: Healthcare Facility of the Future. This proved to be a very successful initiative both for the UIA and the PHG attracting entries from all over the world. The final judging occurred during the China Hospital Construction Conference in May 2017, and the winners were announced at the Annual Meeting in London in June 2017.

I wish to commend the work of Zhipeng Lu in organizing this student competition and to all the UIA-PHG members who freely gave of their time to act as jury members in assessing the winning entries. Information about the winners can be found at: <https://www.uia-phg.org>

2018 UIA-PHG Student Competition

In 2017, the UIA International Competition Commission approved a Student ideas competition to be conducted by the UIA-PHG in conjunction with the 2018 IHPS and Paris Healthcare Week, Paris France. The theme of the student competition was to design a Prefabricated Modular Community Health Center. The competition closes April 30th, 2018. The final judging will occur during the Paris Healthcare Week in May 2017, and the winners will be announced during the IHPS.

I wish to commend the work of Martin Fiset, Canada and Thomas Schinko, France in organizing this student competition and to all the UIA-PHG members who are freely giving their time to act as jury members in assessing the winning entries. Global University Programs in Healthcare Architecture (GUPA)

In accordance with the decision taken at the UIA-PHG Annual Meeting held in Toronto in September 2013, all future meetings of GUPA will be held in conjunction with the annual seminars of the UIA-PHG. The 2018 annual meeting for the GUPA will be held in conjunction with the 2018 UIA-PHG Seminar in Paris. The aim of the annual meeting is to share information and developments in the practice of teaching students of healthcare architecture courses undertaken in the countries represented by the UIA-PHG.

Collaborative Partnerships

Members of the UIA-PHG continue to have productive discussions with the World Health Organization (WHO), the International Hospitals Federation (IHF), SALUS, and the Centre for Health Design (CHD) regarding initiatives that can jointly be supported by the UIA-PHG and these bodies.

World Health Organization (WHO)

In 2016, discussions occurred with the World Health Organization (WHO) regarding the joint production of a Safe Hospital Framework with the UIA-PHG providing advice on the physical aspects required to achieve a "safe" hospital.

The UIA-PHG is currently working to again receive formal endorsement of the relationship between WHO and the UIA-PHG. At the 138th session, in January 2016, the WHO Executive Board reviewed the report of our relations and collaboration between the WHO and the UIA-PHG and decided to officially maintain relations with the International Union of Architects. In making its decision, the Board commended the continuing dedication of the UIA-PHG in supporting of the work of the WHO. This formal endorsement of the relationship between the UIA-PHG and WHO covers the period from February 2016 until January 2019 when it will be reviewed again by the WHO.

International Hospital Federation (IHF)

Another initiative is underway with the International Hospitals Federation to jointly undertake research on those aspects of hospital design which can minimize operational costs. A workshop was held with Eric de Roodenbeke, the Director General of the IHF to scope the parameters of this study and investigations are now being undertaken by the IHF to access funding for this research. We are working to have an update on this work at the 2018 IPHS.

A IHF / UIA-PHG working meeting is planned for Monday May 28th, 2018 in Paris at 9:00am. Please contact cliff.harvey.UIAPHG@bell.net for additional information.

SALUS

Productive discussions have also been held with Marc Sansom the Director of the SALUS Global Knowledge Exchange based in London UK regarding the UIA-PHG being registered on the SALUS website to publicise the work undertaken by the Public Health Work Group. Because the work of SALUS is focused on similar areas to the UIA-PHG, both Warren Kerr and Cliff Harvey are on the SALUS Advisory Committee to achieve improved coordination between the activities of both organisations. The exchange of experience and the sharing of knowledge are today essential to avoid reducing the future hospital to a simple concept related to a unique vision of

those who shape it. Architectural evolution is imperative for all players in the healthcare field, but it must be first and foremost a vector for changes impacting organizations and practices to the highest level of any institution.

During the annual seminar held in Dalian, China, in May 2015, the PHG executive committee approved unanimously a motion selecting Paris as the host of the 2018 annual seminar. In doing so, the French capital is following Nairobi (Kenya, 2016) and London (United Kingdom, 2017). This choice of Paris to welcome this annual seminar positions France as prime representative of the whole of Europe.

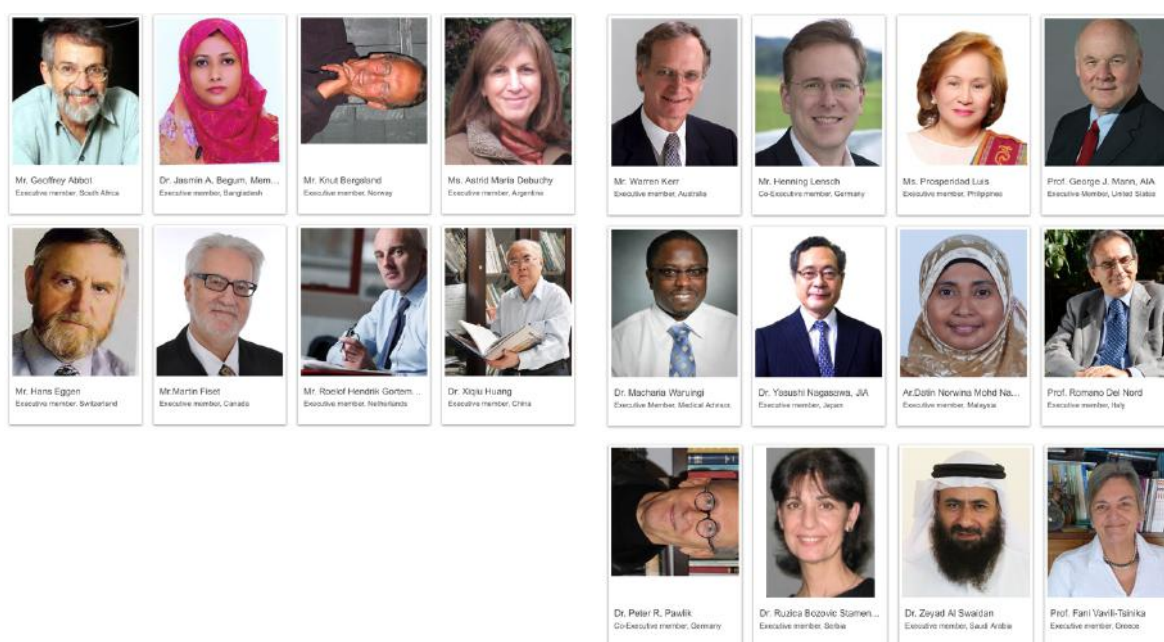

Among the many professional and academic titles, we recall: Past scientific manager of the International Academy of Design and Health and Executive Member of the Board of UIA - PHG (Public Health Group),

President of the Governmental Commission for the improvement of university student housing buildings,

Coordinator of the Master in Safety Planning and Management; Coordinator of the Master in Hospital Planning; Scientific manager of the Convention (of research) between the University of Florence and the

Regional Office of Tuscany on the planning criteria of facilities for Alzheimer sufferers; National and local scientific manager for the project of significant national interest: stress control in healthcare facilities; Group Coordinator for the definitions of "standardized costs for hospital buildings" for the Public Works Supervisory Authority; Member of the integrated technical consulting Committee of the University Hospital Agency of Careggi; Scientific manager of the Italian Society of Hospital Organization. Expert Member of the Commission for the Budget of the Ministry of Health; Trustee of the Careggi Hospitals Foundation in Florence.
